- that Ukrainian bonds are currently trading at less than 50 cents on the dollar, meaning that if repayments continue hedge funds, which are gambling by buying up Ukrainian debt, will make profits of more than 100 per cent;

- chronic discriminatory underinvestment in Palestinian communities in Israel;
- the denial of the right to return of millions of Palestinian refugees as guaranteed by international law;
- the forcible transfer and expulsion of Palestinians from Israel and the OPT;
- the "widespread" and "systematic" use of administrative detention to imprison thousands of Palestinians, including children;
- "decades" of torture and ill-treatment of Palestinian detainees, including children;
- the "systematic, unlawful and arbitrary" killing of Palestinians "outside the context of armed conflict"; and

calls on the Government to endorse the findings and all the recommendations of the Amnesty International report, entitled "Israel's Apartheid against Palestinians: Cruel System of Domination and Crime against Humanity", including but not limited to the following:

- publicly recognise that international crimes against humanity, including the crime of apartheid, as defined in the Rome Statute of the International Criminal Court and the Apartheid Convention, are being committed by Israel against Palestinians in Israel and the OPT;

- request the UN Security Council to:

 - re-establish the Special Committee against Apartheid to focus on all situations, including Israel and the OPT, where the serious human rights violation and the crime against humanity of apartheid are being committed and to bring pressure on those responsible to disestablish these systems of oppression and domination;
- demand that Israel immediately cease all settlement activity as a first step to dismantling all Israeli settlements and related infrastructure in the West Bank;
- further demand that Israel immediately lift the blockade of Gaza and other forms of arbitrary restrictions of movement of people and goods that result in collective punishment;
- request the International Criminal Courts to consider the applicability of the crime against humanity of apartheid within its current investigation of crimes committed in the OPT since 13th June, 2014; and

- inclusion on this list signals to private finance that such projects can be supported, and this will see significant financial flows toward fossil gas and nuclear projects in the coming years;

further notes, in relation to nuclear energy, that:

- in March 2020, the EU's own Technical Expert Group on Sustainable Finance, concluded that it was not possible to say that nuclear energy does not cause significant harm to other environmental objectives and therefore had "not recommended the inclusion of nuclear energy in the Taxonomy at this stage";
- the Platform on Sustainable Finance, an advisory body to the European Commission of over 50 experts from business, academia and civil society, said in its official feedback to the plan that nuclear energy violates a key principle of the Taxonomy, which aims to ensure that any technologies included "do no significant harm" to the environment;
- nuclear energy is not emissions free, with significant carbon dioxide (CO₂) releases from their full life cycle, including the extraction of uranium, transport and construction processes and the demolition of decommissioned sites as well as the storage of waste;
- Scientists for Future stated at the United Nations Climate Change Conference of the Parties (COP26) that "Taking into account the current overall energy system, nuclear energy is by no means CO₂ neutral"; and
- nuclear power plants are about four times as expensive as wind or solar, and take five times as long to build;

also notes, in relation to gas projects, that:

- the International Energy Agency stated last year that any new investment in fossil gas is incompatible with limiting global warming to 1.5 degrees Celsius;
- the Institutional Investors Group on Climate Change have published an open letter objecting to the inclusion of gas in the framework, which they say will undermine the credibility of the Taxonomy and channel capital towards activities not compatible with the EU's commitment to climate neutrality by

- as the Climate Action Network have pointed out, the EU's own 2030 targets of a 55 per cent reduction in CO₂ emissions implies reducing fossil gas consumption across the EU by 32-37 per cent, which is incompatible with more gas investments;
- methane is the primary constituent of fossil gas and that it leaks from every part of the gas supply chain;
- the warming effect of methane is 87 times greater than CO₂ over a 20-year period;

- the Government decision was based on a detailed appraisal and business case prepared by KPMG, with the assistance of Frazer-Nash Consultancy, for the Department of Transport;
- on 22nd December, 2021, the Government commenced the first stage of the tender process by releasing a Pre-Qualification Questionnaire (PQQ) and Response document; and
- on the 23rd and 24th of December, 2021, following queries from the market, several addenda to the PQQ were published;

notes:

- the PQQ states that the minimum requirement is three helicopters and a fixed-wing aircraft on standby for Coast Guard aviation tasking; and
- the number of bases and their location are not specified in the PQQ and instead it states that proposals will be reviewed on their merits and ability to respond in a timely manner which places the onus on the tendering company to configure the base structure for the national SAR provision;

expresses its concern that:

- there is an inherent contradiction in paragraph 1.6 of the PQQ which, while including a provision to potentially issue a separate contract for fixed-wing as an "administrative" measure, states the intention to ultimately select just one proposal to provide the whole service, effectively precluding the Irish Air Corps from providing any part of the next SAR service contract;
- the failure of the Department of Transport to clearly state its strategic requirements may result in legal action from a failed tendering entity and also lead to the closure of at least one of the current bases;
- the Department of Transport fails to recognise a report by the Economic and Financial Evaluation Unit entitled "Future Helicopter Study Group Report (2009)", which agrees that a four-base structure including Dublin, Waterford, Shannon and Sligo is optimal for Ireland;
- there is no evidence that the appraisal process for the next SAR contract has been significantly improved or that a full value-for-money analysis of the existing contract has been carried out, as recommended by the Economic and Financial Evaluation Unit;
- the completed acquisition by CHC Helicopter Group LLC of Offshore Helicopter Services UK Limited, Offshore Services Australasia Pty Ltd., and Offshore Helicopter Services Denmark A/S (previously part of Babcock International plc's corporate group) may reduce the number of companies eligible to tender for the next Irish SAR and may limit competitiveness in tendering;
- despite the Frazer-Nash Consultancy Report 2019 on the operation of Irish national SAR identifying several weaknesses and proposing 13 specific actions, just four have been completed and published to date;
- the service level agreements with the Department of Defence for the provision of fixed-wing SAR top cover on an "as available" basis was a serious flaw in the last SAR arrangement as it did not require or guarantee the 24/7/365 capability required by the IRCG; and
- not having a 24/7 manned helicopter base in Waterford would result in extended travel times for helicopter transfer, further reducing treatment options and outcomes for south east patients, as the present Waterford based R117 service is used as an emergency helicopter patient transfer vehicle for acute heart attack treatment at Cork University Hospital from University Hospital Waterford (UHW) when the UHW cardiac cath lab is closed 129 hours each week; and

 - extraction of the materials;
 - quantity of the materials;
 - manufacture, fabrication, construction, maintenance, and end of life; and
 - the transportation emissions between all of these actions;
- over the last decade, Ireland has seen some of the most progressive regulations in the world, with the implementation of green energy policies, including Part L of the Building Regulations (Conservation of Fuel and Energy – Dwellings) in 2008, 2011 and 2019;
- these regulations have fostered innovation in the construction sector, enabling Irish contractors and building professionals to be at the cutting-edge of energy efficiency in Europe, and the Part L regulations have also made our homes warmer, ventilated and brought more people out of fuel poverty than any other policy;
- embodied carbon is currently not measured in Ireland, and what is not measured is not managed or reduced;
- without measurement of carbon emissions associated with the products used to construct buildings there is a lack of transparency;

- globally, governments have been adopting mechanisms to measure and reduce the embodied carbon of buildings and the products used to construct them and these include the use of Environmental Product Declarations or, for example, in Holland the use of Environmental Cost Indicators, and further to this the European Union (EU) Commission has created Level(s) – A common EU framework of core sustainability indicators for office and residential buildings, which is a reporting system to encourage governments to measure the full carbon impact of buildings and their components across their life cycle;
- the "Climate Action Plan 2019 – To Tackle Climate Breakdown" includes several actions to support the development of low embodied carbon materials from the agricultural and forestry sector, including:
 - prioritising decarbonisation as part of enterprise agency strategies (Action 36);
 - increasing the use of low carbon materials (Action 118);
 - implementing the Forestry Programme 2014-2020 (Action 116); and
 - the National Bioeconomy Implementation Group mandated to examine the circular bioeconomy potential of harnessing the value from side-streams from both agriculture and forestry (Action 117);
- the recent Sustainable finance taxonomy – Regulation (EU) 2020/852 on what can be considered green investment now require evaluation of embodied carbon for larger buildings;
- the Climate Action and Low Carbon Development (Amendment) Act 2021 commits Ireland to net-zero carbon emissions by 2050, Ireland is therefore obliged to bring forward targets for the phased reduction and regulation of embodied carbon in construction, as is already happening in other European countries such as Denmark, the Netherlands, Sweden, France and Finland; and
- setting carbon limits is the most effective means for the decarbonisation of buildings across their full life cycle; and

urges the Government to:

- bring forward a plan for the regulation of embodied carbon in construction, as is already happening in other European countries;
- immediately require the measurement of embodied carbon in all publicly funded projects and set appropriate limit values;
- instruct the Department of Public Expenditure and Reform, and the Construction Sector Group established by that Department, to make carbon management and climate change action a central part of their remit, and the group should also be given the remit of looking at improving the productivity of the construction sector, including actions on modern methods of construction and digitalisation, and efficiency of construction from a carbon management perspective is also critical and must be addressed within this group;
- modify the Department of Public Expenditure and Reform Public Spending Code for the appraisal of capital investment projects (circular 18/2019) to consider the embodied carbon of projects;
- instruct the Minister for Housing, Local Government and Heritage to issue guidance to the local authorities on evaluation of embodied carbon within their development plans; and
- instruct the Department of Housing, Local Government and Heritage to begin the process of developing appropriate building regulations, setting out time relevant targets to meet the national climate change 2030/50 commitments.
